# VOLUNTARY ANNOUNCEMENT ENTERING INTO THE COOPERATION FRAMEWORK AGREEMENT IN RELATION TO A PROJECT IN TIANJIN

This announcement is made by Semiconductor Manufacturing International Corporation ("**SMIC**" or the "**Company**", together with its subsidiaries, the "**SMIC Group**") on a voluntary basis.

#### **COOPERATION FRAMEWORK AGREEMENT**

The Company announces that on 26 August 2022, the Company, Tianjin Xiqing Economic Development Group Co., Ltd (天津市西青經濟開發集團有限公司) and Tianjin Xiqing Economic and Technology Development Area Management Committee (天津西青經濟技術開發區管理委員會) had entered into a "SMIC Tianjin 12-inch wafer production line cooperation framework agreement" (the "Cooperation Framework Agreement").

Pursuant to the Cooperation Framework Agreement, the Company intends to build a 12-inch wafer production line, which the products will be applied to communication, automotive electronics, consumer electronics, industry and other fields. It is intended that the production line will be located in the XEDA Sci-Tech Park in the Xiqing Development Area (西青開發區賽達新興產業園). It is expected that the production line will have a production capacity of 100,000 12-inch wafer per month (the "**Project**"), providing wafer foundry and technology services on process nodes of 28 nanometer ~ 180 nanometer. The Company shall establish a production-oriented independent legal person company (the "**Xiqing New Company**") in the Xiqing Development Area through its wholly-owned subsidiary. The Xiqing New Company shall have a registered capital of US\$5 billion and the total investment sum in the Project will be US\$7.5 billion. The Xiqing New Company will be operated and managed by the Company. The Company shall undertake that the Xiqing New Company will participate in the bidding of a plot of land in the Xiqing Development Area for the construction of the Project according to the agreed conditions and procedures.

Tianjin Xiqing Economic Development Group Co., Ltd and Tianjin Xiqing Economic and Technology Development Area Management Committee agree to provide the Company with land use support, project industry support, project talent support, project infrastructure support and other project support.
